Safety of the goods carried by the Railways

- *41. SHRI KALRAJ MISHRA: Will the Minister of RAILWAYS be pleased to state:
- (a) whether it is a fact that goods carried by the Railways which was over 88 per cent in 1970s have come down to merely 40 per cent in late 1990s;
- (b) if so, how far lack of safety of carriages, pilferage of goods, spreading corruption and ill-maintenance of rail-wagons and other equipments are responsible for the less earnings of the Railways from goods and freight; and
- (c) what additional safety measures and other steps including raids are being taken by Government this year?

New fertilizer policy

- *42. SHRI EKANATH K. THAKUR: Will the Minister of CHEMICALS AND FERTILIZERS be pleased to state:
- (a) whether it is a fact that the Government's new fertilizer policy to remove anomalies in the 2003 pricing strategy is caught in the web of red tape;

- (b) whether it is also a fact that the delay in announcing the new policy is virtually choking the operations of some public sector companies like Fertilizers and Chemicals Travancore Limited (FACT) and Madras Fertilizers Limited (MFL); and
- (c) if so, the reasons for delay in announcing new policy?

Female foeticide and sex selective abortions in Himachal Pradesh

- (a) whether the prime cause of stampede and resultant deaths at New Delhi railway station recently was due to issuing of unreserved tickets to destinations in Bihar much beyond the capacity;
- (b) whether to derive more revenue Railways permit unreserved passengers to travel in reserved sleeper coaches much beyond capacity causing inconvenience and harassment to reserved passengers; and
- (c) what steps are being proposed to lessen the crowd on platforms including

Accident in Sky Bus Metro Rail

- (c) the results of any fresh review undertaken on the safety aspects of the project and also on the feasibility and/or desirability of its commercial introduction as an alternative urban transportation device to underground metros and over land rail tracks?

- (c) if so, the names of said officers of the rank of section heads and above; and
- (d) the action taken/proposed to be taken against those responsible for creating financial mess?
