# Loans for self-employment schemes by banks

- (a) whether it is a fact that during the recent Conference of the State Ministers of Rural Development, Panchayati Raj and Public Works, it was highlighted that the Nationalised Banks were sitting tight on loan applications for self-employment schemes in rural areas and this was hampering the rural development;
- (b) if so, Government's response thereto; and
- (c) the steps taken/proposed to be taken in order to expedite the release of bank loans for self-employment projects in the rural sector?
