- (d) whether his Pakistani counterpart has been urged upon to investigate into the source of leakage at his end;
  - (e) if so, response from Pakistan thereto;
  - (f) if not, the reasons therefor; and
- (g) the measures taken, if any, to ensure pre-journey confidentiality of passengers?
