Visa-rackets

Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether Government are aware of the increasing visa-rackets in the country;
- (b) if so, the places where such visarackets are taking place; and
 - (c) the action taken to curb them?

Installation of computers in police stations in Delhi

Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether Delhi Police propose to install computers at certain police stations to ensure early availability of data which can help in expeditious investigation of cases;
- (b) if so, the number of police stations where computers have been or are proposed to be installed; and

(c) by when computers will be in place at all the police stations?

Inclusion of regional language in the Eighth Schedule of Constitution
