Scarcity of snake-bite serum

- (a) whether Government's attention has been drawn to the news-item captioned, "Snake-bite serum gets scarce", which appeared in the 'Times of India', dated 18th July, 2002;
- (b) if so, the response of Government in this regard;
- (c) whether Government have any proposal to import horses for the production of anti-snake serum to tide over the crisis; and
- (d) any other measures Government propose to take to stave off the crisis?
