### Amendment of Indian Forest Act, 1927

\*181. SHRI GIREESH KUMAR SANGHI: DR. T. SUBBARAMI REDDY:

Will the Minister of ENVIRONMENT AND FORESTS be pleased to state:

- (a) whether Government are considering to amend the Indian Forest Act, 1927;
- (b) if so, whether Government have also decided to pass the Scheduled Tribes (Recognition of Forest Rights) Bill;
- (c) whether the Forest Conservation Act, 1980 which expanded IFA's scope by centralizing State powers over forests made the prior approval of the Central Government necessary for dereservation of reserved forests for use of forest land for non-forest purposes; and
- (d) by what time the Bill is likely to be introduced and passed?

### Anthrax disease

- \*182. SHRI N.K. PREMA-CHANDRAN: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:
- (a) whether any State in the country is under Anthrax threat and if so, the details of cases of Anthrax disease reported so far, State-wise;

- (c) whether any package of assistance has been made available to the State Governments under the Centrally sponsored schemes to control the disease?

- (e) whether Government would also ban residential use of agricultural land to increase the production of wheat and various other crops, if not, the reasons therefor?

#### **Expansion of RINL**

  - (b) if so, the details thereof;
- (c) whether it is also a fact that Government are seriously thinking of merging RINL with SAIL;
  - (d) if so, the reasons therefor;
- (e) whether any consultations with State Government and the major political parties of the State have been held; and
- (f) if so, what are Government's views thereon?

## Impact of Patent Laws on pharma sector

- (d) if so, what will be the extent of unemployment due to closure of units; and
- (e) what steps are being taken to absorb the skilled manpower of the closed units?

### Streamlining Healthcare system

Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:
