### National Highways in Assam

- \*221. SHRI DWIJENDRA NATH SHARMAH: Will the Minister of ROAD TRANSPORT AND HIGHWAYS be pleased to state:
- (a) whether Government have sanctioned any amount for construction and widening of various National Highways in Assam;
  - (b) if so, the details thereof; and
- (c) the details of the funds likely to be released for the purpose?

# Separate account for different services

- \*222. SHRIMATI S.G. INDIRA: Will the Minister of COMMUNICATIONS AND INFORMATION TECHNOLOGY be pleased to state:
- (a) whether Telecom Regulatory Authority of India has ordered phone companies to maintain separate account for different services they provide;
  - (b) if so, the details thereof;
- (c) whether TRAI has taken any steps to ensure prevention of cross-subsidisation by phone companies; and
  - (d) if so, the details thereof?

#### Status of SSIs

- \*223. SHRI SURESH PACHOURI: Will the Minister of SMALL SCALE INDUSTRIES be pleased to state:
- (a) the present status of the small scale industries, so far as production and employment generation are concerned;
