#### FDI in civil aviation sector

## \*21. PROF. ALKA BALRAM KSHATRIYA:

DR. T. SUBBARAMI REDDY:

Will the Minister of CIVIL AVIATION be pleased to state:

- (a) whether he recently met the Minister of Commerce to discuss broad contours of allowing foreign direct investment in civil aviation sector and chart out a road map for putting in place a civil aviation policy which would send the right message to investors;
- (b) whether Government are also keen to bring out greater transparency in the Rs. 20,000 crores worth aircraft fleet acquisition plan of Air India and Indian Airlines; and
- (c) if so, to what extent Government are providing help and assistance to improve Air India and Indian Airlines?

- (c) if so, whether Government have considered their suggestions; and
- (d) if so, what steps are being taken to improve rural banking in the country?

- (c) whether it is also a fact that according to the preliminary estimates, an investment of Rs. 46,000 crores is needed for interlinking of 30 rivers and construction of 32 dams in the country; and
- (d) if so, in what manner Government are thinking of mobilising resources for this megaproject?

#### Floods in Bihar
