#### **Reduction in Holidays**

\*241. SHRI LALITBHAI MEHTA: SHRIMATI SAVITA SHARDA:

Will the Minister of PERSONNEL, PUBLIC GRIEVANCES AND PENSIONS be pleased to state:

- (a) the number of days a year, the Government of India employees work considering holidays of Saturdays, Sundays, Gazetted Holidays, Restricted Holidays and various types of leave availed by them;
- (b) whether Government have examined the possibility of reducing the Gazetted Holidays by permitting employees of respective religious faiths a holiday on that particular day and avoid closing of Government offices;
- (c) whether Government have also examined the possibility of restoring a six day week to increase the number of working days; and
- (d) whether Government propose to conduct any study on the effects of observance of so many holidays on developmental works and routine administration of Government of India?

#### Establishment of a Fluoride Mitigation Centre in Gujarat
