Plans for development of tourism

- *181. SHRI T.T.V. DHINAKARAN: Will the Minister of TOURISM be pleased to state:
- (a) whether it is a fact that perspective plans of 20 years for developing tourism in the States have been prepared.
- (b) if so, the details and the target of these plans; and
- (c) the details of plans envisaged in respect of Tamil Nadu?

Competition in market place

- (a) whether Government considers promoting competition a serious policy issue as envisaged in the National Common Minimum Programme and other statements made from time to time by Government; and

have taken to ensure competition in the market place?

Support and suggestions from World Bank on water related issues

- *183. SHRI B.K. HARIPRASAD: Will the Minister of WATER RESOURCES be pleased to state:
- (a) whether the World Bank has enhanced the quantum of its loan for water-related sectors in India from \$200 million a year to \$800 million a year for four years;
