Cut in CNG supply to industrial units

- *581. SHRI RAJEEV SHUKLA: Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:
- (a) whether it is a fact that Compressed Natural Gas supply to many industrial houses has been cut to meet its increased demand in Delhi;
- (b) if so, the loss of production of industrial units with depleted CNG supply;
- (c) by when the Indraprastha Gas Ltd. (I.G.L.) will be able to meet the full requirement of Delhi; and
- (d) the steps taken to increase the supply of Compressed Natural Gas to industrial units?

Income tax dues from sports personalities

- *582. SHRI H.K. JAVARE GOWDA: Will the Minister of FINANCE be pleased to state:
- (a) the details of income tax dues from sports personalities in the country for the last three years;
 - (b) the number of cricketers who were
