Joint venture of KIOCL

- (b) the contribution to equity made by KIOCL to Joint Venture Co. and the reasons for non-allotment of shares;
- (c) the amount of loan granted and the interest realised; and
- (d) the reasons for grant of concessional loan and the loss caused in interest thereof?

Expansion of area under bamboo
