## Protecting sugar industry

- (a) whether it is a fact that Government pruned sugar export support for three schemes looking into dwindled stocks and bullish prices in the domestic market; and
- (b) if so, the measures Government are taking to protect the sugar industries from incurring losses?

## New trains in Andhra Pradesh

- \*62. SHRI RAVULA CHANDRA SEKAR REDDY: Will the Minister of RAILWAYS be pleased to state:
- (a) whether the State Government of Andhra Pradesh has sought new trains connecting Secunderabad and Chennaivia Kurnool, Inter-City Day Express between Secunderabad and Cuddapah and another connecting Vijayawada and Chennaivia Guntur; and
- (b) if so, the action proposed in this regard?

## Spurious drugs and synthetic milk
