#### Import of electronic waste from U.S.A.

- \*381. DR. C. NARAYANA REDDY: Will the Minister of ENVIRONMENT AND FORESTS be pleased to state:
- (a) whether it is a fact that electronic waste is exported from U.S.A. to Asian countries, including India;
- (b) whether the waste is hazardous for public health; and
- (c) if so, what safety measures are being taken by Government in this regard?

#### Biotech alliance with USA

- \*382. SHRI PREM CHAND GUPTA: Will the Minister of SCIENCE AND TECHNOLOGY be pleased to state:
- (a) whether it is a fact that India and the United States have formed a biotech alliance under the aegis of US-India Economic dialogue;
- (b) whether this alliance would work towards collaboration in research areas and international trade treaties; and
- (c) if so, what are the details of this agreement and the scope of the cooperation?

#### Kendriya Hindi Sansthan, Agra

- \*383. SHRIMATI GURCHARAN KAUR: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to refer to answer to Unstarred Question 1418, given in the Rajya Sabha on the 15th March, 2002, and state:

  - (b) if so, the details thereof; and
  - (c) if not, the reasons therefor?

## Child malnutrition

- (a) whether it is a fact that 47 per cent of child population suffers from severe malnutrition in India, as reported by UNICEF;
- (b) whether Government have any plan to address this problem;

- (d) whether Government have ever conducted any specific studies or asked any social or academic units to do so;
- (e) if so, what are the results of these studies: and
- (f) the remedial measures Government propose, to rectify this sad state of affairs?

#### Patent for cow urine distillate

Will the Minister of SCIENCE AND TECHNOLOGY be pleased to state:

- (a) whether the United States has granted a patent to a product which contains distilled portions from pure cow urine and increases the activity of antibiotics, anti-fungal agents and anti-cancer drugs;
- (b) if so, the names of institutions which helped in research work of this project;
- (c) the number of scientists who worked on this project;
- (d) on which drugs experiments were carried; and
- (e) whether Government have acclaimed it as a major breakthrough?

#### **Environmental clearance by Reliance Industries Limited**

#### Wells in Gir Forests

#### Dowry deaths
