Pollution of underground water

Will the Minister of WATER RESOURCES be pleased to state:

- (a) whether Government's attention has been drawn to the report of the School of Environmental Sciences of Jawaharlal Nehru University which says that underground water is getting highly polluted due to a landfill arising in the form of hills in the Capital and in its bordering areas;
- (b) if so, the steps being taken by Government to curb this;
 - (c) if not, the reasons therefor; and
- (d) the concrete arrangements being made by Government to check pollution of ground water and by when?

Optimum use of runways at Delhi and Mumbai airports

Will the Minister of CIVIL AVIATION be pleased to state:

- (a) whether it is a fact that there are major delays for landings and take-offs at Delhi and Mumbai airports due to lack of runway space, etc.;

- (e) the steps proposed to call in outside experts to devise new systems for use of runway space, etc.?
