- (a) whether it is a fact that Government are considering the revival of the Gorakhpur and Sindri units of the Fertilizer Corporation of India, by setting up gasbased brownfield fertilizer plants at the existing sites;
 - (b) if so, the details of the proposal;
- (c) whether it is also a fact that GAIL has agreed to supply gas to the units by 2010; and
- (d) by when the units are scheduled to be operational?

Complaints against slaughter houses causing environmental pollution
