#### Bomb blasts in Jammu and Kashmir

- (a) whether Srinagar (Jammu and Kashmir) experienced serial bomb blasts on the 14th April, 2006;
- (b) if so, the number of persons who died and those who were seriously injured as a result thereof;
- (c) the number out of them who were civilians, para-military/army personnel and the terrorists involved, separately;
- (d) the terrorist organizations responsible for these blasts;
- (e) the number of terrorists responsible for the blasts apprehended so far; and
- (f) the follow up action taken to avoid such incidents?

#### Funds received by NGOs

- \*362. SHRI RAMDAS AGARWAL: Will the Minister of COMMERCE AND INDUSTRY be pleased to state:
  - (a) how many Non-Governmental

Organizations (NGOs) under his Ministry are in receipt of the Central funds;

- (b) whether these NGOs are regularly submitting the required utilization certificates; and
- (c) if not, what action Government are contemplating to take against the defaulting NGOs during 2005-06, till date, NGOwise?

#### **Export of iron-ore**
