### Size of public holding in a company

- (a) whether it is a fact that SEBI is in favour of hiking the minimum size of public holding in a company from 10 to 25 per cent:
- (b) if so, what are the details in this regard; and
- (c) by when a final decision is likely to be taken?

## Deposits Insurance Corporation for NBFCs

- \*282. SHRI DIPANKAR MUKHERJEE: Will the Minister of FINANCE AND COMPANY AFFAIRS be pleased to state:
- (a) whether there is any proposal under Government's consideration for dealing with the risks and concerns of the depositors, whose money is held by the Non-Banking Financial Companies; and
- (b) whether Government would initiate steps to promote a Deposits Insurance Corporation for the Non-Banking Financial Companies?

- (c) the estimated foreign exchange earned during the last one year from tourism industry and whether this income is less as compared to the previous year?

- (d) what steps are being taken to speed up reforms for higher growth?

### **Income Tax mobilisation**
