Working Group on Minimum Wages

*141. SHRI C. RAMACHAND-RAIAH: SHRI ABANI ROY:

Will the Minister of LABOUR be pleased to state:

- (a) whether the Working Group on Minimum Wages (WGMW) has recommended minimum wage of Rs. 66/per day to the labourer;
- (b) if so, what are the details thereof; and
- (c) whether Government have received complaints regarding non-payment of wages at Government prescribed rates from various quarters, and if so, what steps Government propose to take to ensure the payment of minimum wage of Rs. 66/- per day to the labourer?

Regional Passport Office, Bangalore

- *142. SHRI K.B. KRISHNA MURTHY: Will the Minister of EXTERNAL AFFAIRS be pleased to state:
- (a) the number of passport applications/renewal applications received by the
