Grant-in-aid for strengthening of ISM&H departments

*401. SHRI V. V. RAGHAVAN: SHRI J. CHITHARANJAN:

Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) the amount sanctioned a Grant-inaid to various States for strengthening of existing ISM&H undergraduate departments and upgradation of undergraduate departments to postgraduate departments for the years 2001-2002 and 2002-2003; and
- (b) the criteria on which the Grant-inaid to each State is decided?

Educational low-powered FM radio stations

- *402. SHRI EDUARDO FALEIRO: Will the Minister of INFORMATION AND BROADCASTING be pleased to state:
- (a) whether Government have received proposals from universities or deemed universities to run educational low-powered FM radio stations;

- (b) if so, the decision taken on the same;
- (c) the progress in setting up 40 radio stations of the IGNOU in various parts of the country;
- (d) the cities/States where these stations have been set up, and the places where these are yet to be set up; and
- (e) the funds made available for this purpose?

Incidence of kidney stones

- *403. SHRI NANA DESHMUKH: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:
- (a) whether Government's attention has been drawn to the news-item captioned, "North India's eating habits, climate cause kidney stones", which appeared in the 'Hindustan Times' dated 26th July, 2002;
- (b) whether it is a fact that the incidence of kidney stones is rising in Delhi and adjoining States mainly because people here consume fatty, milk-based food and a lot of fried food whereas South Indians eat steamed food;

- (c) if so, whether Government propose to use electronic media to make the public aware of all such diseases: and
 - (d) if not, the reasons therefor?

Punishment for construction of dry latrines

- (a) whether construction of dry latrines is unlawful under the Employment of Manual Scavengers and Construction of Dry Latrines (Prohibition) Act, 1993;
- (b) if so, the number of people punished/ fined for construction of dry latrines since the enactment of the Act, State-wise;
- (c) the reasons for implementation of this Act only in fifteen States at present; and
- (d) the steps taken to impress upon all the States to adopt and properly implement this Act?

Extension of Purchase Preference Policy

- (a) whether Government have decided to extend Purchase Preference Policy for products and services of Central PSUs, which had expired on 31st March, 2002;

 - (c) if not, the reasons therefor; and
- (d) the steps taken by Government to make PSUs efficient, competitive and self-supporting?

Sale of ITDC hotels

- *406. SHRI YADLAPATI VENKAT RAO: Will the Minister of DISINVESTMENT be pleased to state:
- (a) the number of ITDC hotels, so far, sold off;
 - (b) the number of hotels yet to be sold; and
- (c) the details of ITDC hotels not to be sold off and the fate of the employees of ITDC hotels already sold?

Labelling on soft drinks

- *407. SHRI PRITHVIRAJ CHAVAN: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:
- (a) whether Government are aware of the harmful effects of carbonated soft drinks on health and their habit-forming nature;
- (b) whether Government are also aware that many foreign countries make it mandatory to label soft drink bottles and cans with warning about presence of caffeine, calorie content and the type and amount of sweetener used;
- (c) whether Government have conducted any study to find out which foreign country has regulations for such compulsory markings;
- (d) whether Government have any plan of introducing such mandatory labelling of soft drinks in the country; and
 - (e) if not, the reasons therefor?

Cheaper Hepatitis-B vaccines

- (c) whether cheap vaccines are available in the country for the poor; and
- (d) if not, the steps being taken to procure Hepatitis-B vaccines at cheaper rates?

Use of the title 'Doctor'
