Schemes of National Horticultural Board

- *281. SHRI MATILAL SARKAR: Will the Minister of AGRICULTURE be pleased to state:
- (a) the percentage of horticultural land in the country, State-wise;
- (b) the number of schemes implemented by the National Horticultural Board in the country and in the North-Eastern States:
- (c) the percentage of the horticultural produce processed during the years 2002-03, 2003-04 and 2004-05; and
- (d) whether Government are planning for processing horticultural produce in a larger quantity to avoid wastage of the produce?

Sickle Cell disease in Chhattisgarh

- *282. SHRIMATI MOHSINA KIDWAI: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:
 - (a) whether Government are aware that

almost ten thousand people die in Chhattisgarh due to Sickle Cell disease;

- (b) whether Government would consider establishing a Sickle Cell Unit in the State to provide test facilities at all district centres in Chhattisgarh; and
- (c) if not, the reasons therefor and what steps Government are taking to provide cheap and reliable blood test alongwith the details of facilities offered till date?

Pampa Action Plan

- *283. PROF. P. J. KURIAN: Will the Minister of ENVIRONMENT AND FORESTS be pleased to state:
- (a) whether Government have approved the Pampa Action Plan to clean and protect the Pampa river in the State of Kerala;
 - (b) if so, the details thereof;

- (d) in how much time the plan is expected to be implemented fully?

Major rivers choked with industrial effluents

- (a) whether a number of major rivers and their tributaries are choking with industrial effluents and other pollutants;
- (b) if so, what are the details in this regard and the programmes initiated by Government to clean the rivers indicating the amount spent thereon during the last three years;
- (c) whether it is a fact that heavy discharge of sewage water in the Yamuna River is creating havoc with the aquatic life in the river and defeating the River Conservation Plan; and
- (d) if so, the details thereof and the corrective steps taken in this regard?

Target for agricultural growth

- (d) whether it is a fact that the Prime Minister announced during the meeting that the Population Policy of the country does not encourage incentives and disincentives; and
- (e) if so, the manner in which Government propose to control population without any incentives and disincentives?

- (c) if so, by when Government would make arrangements for display of the extent of pesticides on the labels of food items?

- (d) what additional measures are being taken to strengthen anti-poaching measures;
- (e) whether Government are considering setting up an expert group to monitor the reserves; and
 - (f) if so, the details of its mandate?

Checking MRP violations

- (c) whether the Commission has sought to promote coordination in planning and implementation of population policies across the Central and State Government agencies; and
- (d) if so, upto what extent the Commission is likely to achieve these aims and objectives?

Ban on Indian Ayurvedic drugs by Canada

- (g) what steps Government propose to take to improve availability of doctors and also set up new medical colleges in those States where there is deficiency?
