Disaster Management

- *441. DR. ARUN KUMAR SARMA: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) the names of various national and international institutions engaged in disaster management in the country since 1996 indicating their location, mandate, achievement and future targets and financial involvement of GoI: and
- (b) the consensus arrived at various National level meetings and all party consultations by Prime Minister on Disaster Management indicating date-wise consensus, implementation status and targets set for its final take off?

Food for Work Programme

- †*442. SHRI MANOHAR KANT DHYANI: Will the Minister of RURAL DEVELOPMENT be pleased to state:
- (a) whether it is a fact that about 32 lakh tons of grains have been provided free of cost by Government to the various State Governments under the Food for Work Programme;
- (b) if so, the quantity of grains allocated to Uttaranchal and Uttar Pradesh under the said Programme separately; and

(c) the State-wise details of grains disbursed under the said programme till June, 2002?

Review of schemes for BPL families

- (a) whether Government have conducted any review regarding various schemes for the Below Poverty Line (BPL) Families;

- (d) whether Government propose to review the existing patterns for identifying the BPL beneficiaries; and
 - (e) if so, the details thereof?

Formation of Tourist Police Force

- *444. SHRI K.B. KRISHNA MURTHY: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) whether Government are aware of the fact that many foreign tourists land in India on tourist/business visas without

- (b) if so, what is the police mechanism to check overstay of such tourists; and
- (c) whether Government propose to constitute a Tourist Police Force to check this growing menace?

Mechanism to declare a country/outfit as terrorist

- (a) whether there is some mechanism to declare a country/outfit, as terrorist country/outfit;
- (b) if so, whether there is a website or a publication which publishes names of such outfits, individuals or a country;
 - (c) if so, the details thereof;
- (d) if there is no mechanism presently for the purpose, whether Government is contemplating to develop such a mechanism;
 - (e) if so, how and by when?

Subsidy on Wind power electric generating units

- (a) whether there is a subsidy on import of machinery/parts of wind power electric generating units;

- (d) if so, the details of cost of an imported wind power unit and a similar KV unit manufactured in India; and
- (e) whether Government propose to withdraw the subsidy offered on import of such machines or equipments?

Connecting Satpuli-Viyasghat Road, Uttaranchal through PMGSY

- *447. SHRI ANIL SHARMA: Will the Minister of RURAL DEVELOPMENT be pleased to state:
- (a) by when Government propose to connect Allasu, Bhatoti, Kunkuli, Kismola, Madosen, Thanul, Kwata, Chondil, Silwar, Jokhnoli and Patti Maniyarsun villages in Uttaranchal with all whether road under PMSGY as the present population of the above hilly villages have crossed 250 persons; and
- (b) whether Government would impress upon the State Government and PWD to construct the said Satpuli-Viyas ghat road so that the villages of said area could be connected with the main transportation line of the region?

Gas based power projects in Nagaland

- (a) the States engaged in Sericulture cultivation and silk industry;
- (b) the quantities produced in each State during 1998-1999, 1999-2000, 2000-2001 and 2001-2002;
- (c) the average price of 1 Kg of silk during the years 1998-1999, 1999-2000, 2000-2001 and 2001-2002;
- (d) the steps taken to ensure a remunerative price for the silk; and
- (e) the steps taken to prevent dumping of silk into India?

Accelerated Generation and Supply Programme

Construction of cyclone proof record rooms and additional courts in Orissa

- (c) whether Government have urged the Commission to submit their report immediately so that Government may implement the decision taken by the Commission; and
- (d) if so, by when the Commission is likely to submit its report?
