#### **Universal Health Insurance Scheme**

- (a) whether he has recently launched a Centrally heavily subsidized and the cheapest redesigned Universal Health Insurance Scheme (UHIS) targeting people below poverty line;
- (b) if so, the total amount earmarked for UHIS;
- (c) the maximum amount proposed to be given as compensation/reimbursement of hospital expenses for diseases as well as accidental injuries under this scheme;
- (d) the details of the strategy for marketing of this health insurance policy?

## **Investment in Special Deposit Scheme**

(a) whether it is a fact that his Ministry has turned down the proposal of Central

# **Island Special Allowance**

- (a) whether Island Special Allowance is given only to the officers/staff of the nationalised banks who are posted from mainland to the Andaman and Nicobar Islands;

# **Increase in Government borrowings**

- (c) whether the RBI has cautioned Government not to cross the fiscal deficit target?

## Supply of gas to Southern States
