Sale of Reliance shares to fake firms

*181. SHRI JIBON ROY: SHRI SANJAY NIRUPAM:

Will the Minister of FINANCE be pleased to state:

- (a) whether Government are aware that Reliance Infocomm has sold a total of one crore preferential shares to three fake firms at the rate of Rs. one each; and
- (b) if so, whether Government would institute an enquiry on the whole affair?

Recovery of revenue from import duty

Will the Minister of FINANCE be pleased to state:

(a) whether it is a fact that the amount recovered through import duty is increasing due to consistent increase in import of edible oil during the preceding years;

- (c) the rates of import duty fixed during the said periods?

Will the Minister of FINANCE be pleased to state:

- (a) the number of persons who have filed Income-tax return after the introduction of one-by-six scheme Under Section 139 of the Income Tax Act, 1961, during each year from 2000-01 to 2003-04;
- (b) income-tax collected during each of these years under the Scheme;
- (c) whether it is a fact that there has been reduction in the number of persons filing return under this category and if so, the reasons therefor; and
- (d) whether Government propose to do away with the requirement in respect of those persons whose income is not taxable and if not, the reasons therefor?

Impact of VAT on tea industry

Reduction in rate of interest by NABARD

- (d) value of fake stamps/stamp paper seized till date?

Irrigation benefit programme
