#### Welfare of Tribals

\*301. SHRIMATI SARLA MAHESHWARI: SHRI A. VIJAYA RAGHAVAN:

Will the Minister of TRIBAL AFFAIRS be pleased to state:

- (a) whether it is a fact that grants for the welfare of tribals were distributed to NGOs which were virtually non-existent;
- (b) if so, the methodology adopted to scrutinize the legitimacy of these organisations while granting funds;
- (c) whether Government initiated any action against the authority concerned for such corrupt practices;
  - (d) if so, the details thereof; and
  - (e) if not, the reasons therefor?

### VRS in PSEs

\*302. SHRIMATI VANGA GEETHA: Will the Minister of HEAVY INDUSTRIES AND PUBLIC ENTERPRISES be pleased to state:

(a) whether Government are coming up with another round of Voluntary Retirement

Scheme for staff of Public Sector Enterprises;

- (b) the number of surplus staff in different PSEs:
- (c) the estimated amount to be paid to separating employees; and
  - (d) the other details in this regard?

# Unauthorised occupation of public land

- \*303. SHRI ABANI ROY: Will the Minister of URBAN DEVELOPMENT AND POVERTY ALLEVIATION be pleased to state:
- (a) whether some of the ground floor allottees of Block No. 21, Lodhi Colony, New Delhi have appropriated the common open space among themselves thus putting the first floor allottees to disadvantage;
- (b) whether some ground floor allottees of aforesaid Block had unauthorisedly occupied the public land beyond the wall;
- (c) whether the C.P.W.D. have also contributed unwittingly in this illegal act

by putting barbed wire-fencing on payment basis?

## Mandatory telecast of channels by Cable networks

# Meeting of CCC and CEC under the Disability Act, 1995

- (a) whether it has been provided in the Disability Act, 1995 that the Central Coordination Committee (CCC) and the Central Executive Committee (CEC) will meet at least once in every six and three months, respectively;
- (b) if so, the number of meetings of CCC and CEC held during the last six years;
- (c) the names of States, which have not appointed State Coordination Committees and the State Executive Committees so far as provided in the Act; and
- (d) the steps taken/proposed to be taken by Government to implement the Act all over the country in letter and spirit?
