#### **Modernisation of Police**

\*701. SHRI RAJU PARMAR: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether Government have granted/sanctioned financial assistance to the Haryana Government for modernisation of police force and purchase of sophisticated equipments;
- (b) if so, what are the details of funds released during the last two years;
- (c) whether State Government has utilized the funds for the said purpose and if not, the reasons therefor; and
- (d) what steps are being taken by Government to ensure that the funds granted/sanctioned are utilized for the purpose they were given, by the Haryana Government?

### Cases against Delhi Police officials

\*702. SHRI B.J. PANDA: Will the Minister of HOME AFFAIRS be pleased to state:

(a) the number of Delhi Police officials facing enquiries in corruption cases;

- (b) the number of policemen punished for corrupt acts during the last two years;
- (c) whether policemen are imparted refresher courses/training periodically to make them public-friendly; if so, the details of such courses; and
- (d) the forum set up to redress the grievances of the policemen?

# Integrated Wasteland Development Programme

# Milk supplier to Goa unit of Indian Navy

- (a) whether it is a fact that Goa unit of Indian Navy has rejected tender of ASC supplier for supply of milk and accepted tender of a Solapur based supplier;
- (b) whether it is also a fact that ASC contractor has been supplying fresh milk procured from Belgaum based cooperative for the last several years and he was issued a certificate for satisfactory service;
- (c) whether Solapur based supplier is supplying preserved milk at higher cost which reaches Goa after 3-4 days of its procurement which is dangerous for health: and
- (d) the reasons for rejecting tender of ASC contractor and accepting tender of Solapur based supplier situated 500 km. away from Goa?
