#### FDI in print media

\*1. SHRI ABANI ROY: DR. ABRAR AHMED:

Will the Minister of INFORMATION AND BROADCASTING be pleased to state:

- (a) whether Government have decided to allow 26 per cent foreign direct investment in print media inspite of stiff opposition;
  - (b) if so, the reasons therefor;
- (c) whether the small and medium newspaper industry in the country is likely to suffer a lot due to this decision; and
- (d) if so, the steps Government are going to take to protect them?

#### Disinvestment of PSUs

- \*2. SHRI C. RAMACHANDRAIAH: Will the Minister of DISINVESTMENT be pleased to state:
- (a) the total number of public undertakings under various Ministries, Ministry-wise;
- (b) the total number of PSUs in respect of which decision has been taken to

disinvest them and proceeds realized after completing the process of disinvestment/ sale;

- (c) the number of PSUs in respect of which a decision has been taken to disinvest but the process not yet completed/proceeds not yet realized after the sale/disinvestment; and
- (d) the number of PSUs still with Government and the steps taken to improve their management and functioning?

### Disposal of surplus land of VSNL

#### Joint venture between India and Iran

- (a) whether India and Iran have decided to take-up joint infrastructure projects in Afghanistan and other countries of the region;
- (b) whether India has offered help to Iran in improving the infrastructure in large cities in Iran, such as Teheran; and
  - (c) if so, the details in this regard?

### Surprise checks of CGHS dispensaries

- (c) whether one of the main reasons for ill-functioning of the CGHS dispensaries is denying promotion to CGHS Staffers;
- (d) if so, the reasons for nonimplementation of the Assured Career Progression (ACP) scheme to CGHS pharmacists; and
- (e) the steps being taken to implement the scheme for them?
