Ban on animal testing

- *361. SHRI MUNAVVAR HASAN: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:
- (a) whether it is a fact that production of anti-snake venom has been stopped;
- (b) whether ban on animal testing is creating hurdles in research and development efforts Pharmaceutical companies in the country;
- (c) if so, the manner in which the companies are now supposed to test the new medicines; and
- (d) the action proposed to help the Indian companies which are compelled to plan animal testing abroad?

Production of commercial vehicles
