Damage to Kirandul-Visakhapatnam rail track due to overloading

- *341. SHRI RAVULA CHANDRA SEKAR REDDY: Will the Minister of RAILWAYS be pleased to state:
- (a) whether it is a fact that the 472 kilometers long rail track from Kirandul to Visakhapatnam is in danger of heavy damage due to overloading of iron ores in goods trains;
- (b) whether some trains were recently cancelled due to damage to the tracks;
 - (c) if so, the details thereof;
- (d) the amount lost due to such cancellation;
- (e) the reasons for not taking prompt action;
- (f) whether the geologists have also expressed fear about this track;
- (g) if so, Government's response thereto; and
- (h) the steps being taken by Government to improve the situation?

Threat from Atmospheric Brown Cloud

- *342. DR. NARAYAN SINGH MANAKLAO: Will the Minister of ENVIRONMENT AND FORESTS be pleased to state:
- (a) whether it is a fact that the Atmospheric Brown Cloud (ABC), a terminology generally used for the enormous blanket of pollution comprising ash, acids, etc., reduces the chances of monsoon rains substantially in the subcontinent thereby causing potential threat to the agricultural harvests;
- (b) if so, the measures taken/proposed to be taken by Government to tackle the threat;
- (c) whether any study to assess its impact on our country has been carried out:
 - (d) if so, the details thereof; and
 - (e) if not, the reasons therefor?

Quality of fruits and vegetables supplied through Mother Dairy outlets

- (c) if so, at what level and whether any irregularities/corruption in the procurement have come to the light; and
- (d) if so, the details thereof and the action taken to ensure reasonable good quality of vegetables and fruits at reasonable prices are made available through Mother Dairy outlets in the State?

Leprosy patients in the country

(d) if so, the details of the existing number of Leprosy patients and their condition, State-wise and the details of action taken by Government in this regard?

Venture capital fund for dairy and poultry industry

- (b) if so, whether Government would ensure that provision of its micro-credit to individual entrepreneurs, unemployed youths, etc. percolates to tribals and other deprived sections of the society for their gainful employment; and
- (c) whether the backward and tribal districts of Chhattisgarh and Yavatmal in Maharashtra would be identified for selective operaton of this scheme for the year 2007, through NGOs or cooperative societies functioning in such districts?

Assistance to Madhya Pradesh for fishery development

- (b) the names of metre gauge lines that are not under such conversion;
- (c) whether in the north-eastern region rail lines are mostly in metre-gauge and due to this reason the goods are subjected to frequent loading and unloading for transportation outside the region causing additional financial burden and this also consumes a lot of time; and
- (d) if so, the steps contemplated to overcome these problems?

Indian Public Health Standards

- (c) the minimum functional grade prescribed for community health centres?

Mangrove forests

Deficient forest cover in Punjab, Haryana, U.P., etc.

- (b) whether declining prices of wood in the context of free import of wood under OGL presents added disincentive to farmforestry:
- (c) if so, whether with the twin objectives of increasing Forest-Tree-Cover (FTC) and generating viable employment opportunities, the Government of Punjab and other State Governments have requested the Centre to provide incentives to farm-forestry while imposing countervailing duties on import of wood and wood products; and
- (d) if so, what is Government's response thereto?

Ticketing system at Bangalore City railway station

 - (b) if so, the details thereof; and
- (c) whether any road map has been drawn to boost production and export of horticulture items in the above States?

Policy for purchase of antibiotics

- (e) the details of items covered under the scheme and the future plans to expand the areas and cover more items especially in drought prone States?

Decrease in agricultural production in Andhra Pradesh
