Falling prices of Indian raw silk

- *41. SHRI K. RAHMAN KHAN: Will the Minister of TEXTILES be pleased to state:
- (a) whether Government are aware of falling prices of Indian raw silk leading to fall in the prices of cocoon affecting farmers of silk production areas;
- (b) whether Government of Karnataka has requested the Union Government for financial assistance to provide minimum support price to silk growing farmers; and
- (c) if so, the steps taken by Government to arrest the heavy import of China Silk?

Rural development projects

*42. SHRI MOOLCHAND MEENA: SHRI NANA DESHMUKH:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) whether it is a fact that the Union Minister has expressed displeasure at the slow implementation of rural projects by States despite adequate allocation of funds by the Union Government;
- (b) if so, whether after a review focusing on the Southern States, the Minister found

that despite a positive response from several States to the Centre's plea for more transparency, the situation at the village level continues to be unsatisfactory;

- (c) if so, which are the States where there has been slow progress in rural projects; and
- (d) what are the suggestions made by the Union Government to the States to implement the rural development schemes vigorously?

Special bulldozers for border fencing

- *43. SHRI YADLAPATI VENKAT RAO: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) whether the Border Security Force engaged in the work of fencing along International Border in Jammu and Kashmir to prevent infiltration have asked for supply of special bulldozers;
- (b) if so, whether it is a fact that in the face of continuous Pakistani firing from across the border, special types of bulldozers are necessary for carrying out digging, levelling and building of bunds; and
- (c) the length of border where fencing has been completed out of the total length to be fenced?

Properties of displaced Kashmiri Pandits

- *44. SHRI MUNAVVAR HASAN: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) whether it is a fact that various departments of Central and State Government of Jammu and Kashmir have taken possession of the properties belonging to displaced Kashmiri Pandits/individuals and religious institutions temporarily/permanently without taking consent of the owners;
- (b) whether it is also a fact that no compensation/rent etc. has been paid to several such owners;
 - (c) if so, the details thereof;
- (d) whether Government intend to take necessary action to pay compensation; and
- (e) if so, by when this is likely to be done?

ISI activities in Leh and Kargil

- *45. SHRI ABANI ROY: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) whether Government are aware of the fact that ISI has been spreading militancy to the peaceful districts of Leh and Kargil of Jammu and Kashmir as reported in the 'Statesman' dated 23rd June, 2002;
- (b) if so, whether Government have chalked out any schemes to crush the nefarious designs of ISI in the country;
- (c) if so, the details thereof and whether the State Government have been alerted/ sounded in this regard; and
- (d) if so, the manner in which such activities of ISI would be controlled?

Foreign equity participation in textile sector

- (a) how many foreign companies have started units after the FDI policy allowed foreign equity participation upto 100 per cent in the textile sector; and

Negotiations with Bodo Militants

- *47. DR. MANMOHAN SINGH: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) the progress made in negotiations with the Bodo Militants led by the Bodo Liberation Tigers (BLT);
- (b) the outstanding issues which remain to be resolved; and
- (c) the steps being taken to involve all militant groups in the peace process?

Decline in turnover of CCICI Ltd.

Godhra incident

 - (d) if so, the findings of the report?

Rate of private banks in serial bomb blasts in Coimbatore

- (a) whether investigations have revealed that four private banks in Mumbai had been used as conduit to carry out the serial bomb blasts in Coimbatore in 1998;
 - (b) if so, the names of the said banks;
- (c) the amount deposited/transferred to Tamil Nadu by these banks; and
- (d) the persons involved in this nefarious act?

Bifurcation of duties of Delhi Police

- *51. SHRI BALWANT SINGH RAMOOWALIA: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) whether Government have recently received any report from the Bureau of Police Research and Development (BPR&D), regarding Delhi Police, as reported in the 'Hindustan Times', dated the 1st July, 2002;
 - (b) if so, the details thereof; and

(c) what action Government have taken so far on the demand of Delhi Police to split law and order and investigation duties?

Capacity addition during Tenth Five Year Plan

- (a) whether it is a fact that N.H.P.C. had formulated a plan to add 5310 MW of power during Tenth Five Year Plan;

- (c) the cost of each of such plants and whether Government will ensure completion of construction work of these plants within stipulated time; and
- (d) whether provision of required funds for installation of all such plants has been made?

Recommendations of High-powered Committee set up by Orissa Government

Supply of sub-standard MIG-21 spares by HAL

- (c) whether it is also a fact that HAL is re-exporting quality spares imported from Russia to Algeria and Vietnam;
 - (d) if so, the reasons therefor; and
- (e) the measures taken to acquire quality spares by IAF to avoid further MIGcrashes?

Providing drinking water to all by 2004

- (e) the steps being taken by Government to implement the scheme of providing drinking water to all by 2004?

Grant of Autonomy to J&K

(a) whether Government's attention has been drawn to the reported press statement by the Chief Minister of Jammu and Kashmir to the effect that the grant of autonomy to the State was a pre-requisite for the return of peace to the valley;

(b) if so, the details thereof and Government's reaction thereto;

- (c) whether it is a fact that during his meeting with the Prime Minister, the Chief Minister reiterated his position and received some assurances from him; and
- (d) if so, the details of the assurance given by the Prime Minister with regard to the demand for autonomy?

Complaint against EU in WTO

- *60. SHRI GHULAM NABI AZAD: Will the Minister of TEXTILES be pleased to state:
- (a) whether the Union Government is planning to lodge a complaint with the World Trade Organisation's dispute settlement panel against the European Union for refusing to extend to it the preferential treatment granted to textile export from Pakistan under the generalised system of preferences scheme;
- (b) if so, whether India has claimed that the differential treatment has led a decrease in its exports of certain textile products to the region during the past few months;
- (c) if so, what is the reaction of the WTO dispute body; and
- (d) whether any settlement has been reached in this regard?
