Tourist information centres at airports

*301. SHRIMATI PREMA CARIAPPA: SHRI ANAND SHARMA:

Will the Minister of TOURISM be pleased to state:

- (a) whether Government propose to set-up round-the-clock tourist information centres at all the International Airports of the country manned by competent and qualified staff to provide information to the tourists: and
 - (b) if not, the reasons therefor?

Leasing of aircrafts by AI

†*302. SHRI MOTILAL VORA: Will the Minister of CIVIL AVIATION be pleased to state:

- (a) whether it is a fact that Air India has taken a decision to take aircrafts on lease;
 - (b) if so, the reasons therefor;

- (c) the number of aircrafts which would be taken on lease and the period thereof;
- (d) how old are these aircrafts and the amount that will have to be paid by Air India for each aircraft every year; and
- (e) the extent to which Air India's earnings will increase every year by taking these aircrafts on lease?

Conference on Panchayati Raj and Rural Development

- (b) whether any work plan to implement the said recommendations has been formulated: and
 - (c) if so, the details thereof?

Self-employment schemes

- *304. SHRI ANAND SHARMA: Will the Minister of FINANCE be pleased to state:
- (a) what are the various selfemployment schemes being run for extending credit to unemployed youth by different banks in different States;
- (b) whether these schemes conform to the local resource availability and the employment based on such resources;
- (c) whether a periodic evaluation is done to judge their efficacy for continuation; if so, the resultant achievements in terms of credit extended for self-employment; and
- (d) the details of the credit schemes, which were initiated but failed to take off to promote sustainable employment and the reasons for their failure?

Loans for SSI

- *305. PROF. M.M. AGARWAL: Will the Minister of FINANCE be pleased to state:
- (a) the total amount of loans sanctioned by various nationalised banks for the setting up of small scale industries in various States during the last three years; and
- (b) what guidelines have been prescribed by Government for granting loans to SSI units in the country?

LPG marketing by private companies

- *306. SHRI RAJEEV SHUKLA: Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:
- (a) whether Indian Oil Corporation has objected to allowing some private companies to sell LPG directly to bulk

- consumers on the plea that the situation will have an adverse impact on State-run marketing companies; and
 - (b) if so, the details in this regard?

Profit by oil companies

- (c) what were the selling prices per litre of diesel and petrol as on 1st April from 1999 to 2004 in different parts of the country?

Coal gassification project of GAIL

- (a) whether GAIL has been examining coal gassification option for commercial projects in eastern parts of the country;
- (b) if so, the details thereof, including the source of technology and the countries, where this technology is being used for power generation and fertilizer production;
- (c) whether Government will extend any fiscal and other support for projects on coal gassification in view of high oil price scenario; and
 - (d) if not, the reasons therefor?

Srinagar airport as international airport

- *309. PROF. SAIF-UD-DIN SOZ: Will the Minister of CIVIL AVIATION be pleased to state:
- (a) whether Government are aware that the people of J & K have been requesting Government for declaring the airport at Srinagar as international airport;
- (b) if so, the details of steps taken in this direction; and
- (c) by when a declaration to this effect would be made?

GDP growth rate

- *310. SHRI VIJAY J. DARDA: Will the Minister of FINANCE be pleased to state:
- (a) what will be the growth rate target in 2004-05 in view of Government's commitment of sustained growth of 7-8 per cent while 8.2 per cent GDP growth achieved in 2003-04 marks the best performance by the economy since reforms began;
- (b) which other sectors, besides farm and agriculture, will be focused so that overall growth rate is further improved upon; and
- (c) whether it is a fact that China has achieved 9.8 per cent growth and whether a comparative study has been made in this regard to learn from their experience, wherever feasible?

GAIL's overseas projects

Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

- (a) whether it is a fact that GAIL proposes to venture into Egypt and other foreign lands in oil and gas sector;
 - (b) if so, the details of the new projects;
- (c) whether it is also a fact that the country is facing deficit in gas sector and propose to import gas from other countries to meet the shortfall; and
- (d) if so, what is the action plan of Government to become self-sufficient in this sector in times to come?

NPAs of banks

- *312. SHRI MANOJ BHATTA-CHARYA: Will the Minister of FINANCE be pleased to state:
- (a) whether the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act passed in 2002 has had any appreciable impact on the recovery management of the banks;
- (b) if so, the details of the Non-Performing Assets of the banks during the last two years *i.e.* 2002-03 and 2003-04, year-wise and bank-wise; and
- (c) by when the outstanding NPA is likely to be fully recovered and what special steps are going to be taken for the purpose?

Shifting of Regional Office of United Bank of India

- *313. SHRI RISHANG KEISHING: Will the Minister of FINANCE be pleased to state:
- (a) whether United Bank of India as the lead bank for Manipur, has shifted its Regional Office from Imphal to Silchar, Assam and has also closed down its five branches;

- (b) if so, the details there of and the reasons therefor; and
- (c) what steps are being taken including finding a new lead bank to accelerate banking activities in Manipur specially in hilly districts?

Growth prospects of civil aviation sector

- (a) the number with names of the public sector and private sector airlines in the country with economic viability;

Village tourism in Tamil Nadu

- (c) whether the target for agriculture finance set for RRBs during the fiscal under review is much higher than what is set for commercial cooperative banks; and
- (d) if so, what efforts are being made to grow more than 40 per cent in future?

Reduction of interest rate on EPF

- (c) whether the financial condition of Government indicts laxity in the recovery of these dues?
