Tourism Projects in Rajasthan

- *381. DR. ABRAR AHMED: Will the Minister of TOURISM AND CULTURE be pleased to state:
- (a) whether it is a fact that out of 237 projects sanctioned for the development of infrastructure in the field of tourism since 2001, only 4 projects have been sanctioned for Rajasthan;
- (b) if so, the names of the projects sanctioned for Rajasthan;
- (c) the amount spent on each of the projects so far; and
- (d) by when the projects are likely to be completed?

Higher interest rates in RRBs

- *382. SHRI K. RAMA MOHANA RAO: Will the Minister of FINANCE AND COMPANY AFFAIRS be pleased to state:
- (a) whether it is a fact that interest rates in Regional Rural Banks (RRBs) are higher than those of commercial banks; and
- (b) if so, the action proposed to take up the right type of restructuring plan for RRBs?

Indo-Italian Co-operation Programme in H.P.

Increase in price of Natural Gas
