#### Violation of labour laws

Will the Minister of RAILWAYS be pleased to state:

- (a) whether Ministry of Railways is aware of the gross violation of labour laws, pertaining to minimum wages, right to form union etc. and anti-workers activities by Hindustan Construction Company (HCC), the contractor engaged in construction work in Banihal in Doda district of Jammu and Kashmir;
- (b) if so, the action taken by the Ministry of Railways, as principal employer, to stop repression directly or indirectly by HCC on the above contractor's workers comprising migrant, dalit and minorities; and
  - (c) if not, the reasons therefor?

## Loss due to increase in price of steel

- (e) if so, whether Government are confident of meeting foodgrain shortage so that the demand of foodgrains by States are fully met?

#### Landscape railway stations

#### Infant deaths

during the last three years, year-wise and State-wise; and

(c) what preventive measures Government have taken, so far, to control infant deaths/gender bias from birth prevalent in certain States like Orissa etc. and need of raising awareness and strengthening laws in this regard?

## Bogie frame of standard gauge
