Additional funds to South Central Railway for passenger amenities

- *241. SHRI NANDI YELLAIAH: Will the Minister of RAILWAYS be pleased to state:
- (a) whether South Central Railway approached Railway Board for grant of additional funds to the tune of Rs. 20 crores during the current year for various passenger amenities;
- (b) if so, whether Government would assure of releasing this additional grant for the current year; and
 - (c) if not, the reasons therefor?

NACO to remove bottlenecks

- *242. SHRIMATI S.G. INDIRA: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:
- (a) whether it is a fact that the National AIDS Control Organisation (NACO) had offered a unique option to remove bottlenecks, streamline communications and ensure better utilisation of funds;

- (c) whether the NACO had signed any Memorandum of Understanding with UNICEF in this regard; and
 - (d) if so, the details thereof?

National Commission on Farmers

- (d) if so, by when a final decision for implementing the schemes prepared would be taken?

Food Parks

- (b) if so, the details of the findings of the WWF expert team in respect of Sariska Reserve, indicating the population of tigers in the reserve according to the last three counts and the causes of depletion in the tiger population; and
- (c) the steps taken or being taken to protect, preserve and promote the tiger population in the Sariska and other reserves and sanctuaries and the results thereof?

Interim report of National Commission on Farmers
