Central Rural Sanitation Programme

- (c) whether the Government of Madhya Pradesh has sent projects for approval to Central Government for 30 districts of the State for inclusion in the said programme; and
- (d) if so, the reasons for not according the approval and by when Central Government are likley to accord sanction for the same?

Expenditure incurred on the security of VIPs
