Currency management of RBI

- *221. SHRIMATI SARLA MAHESH-WARI: Will the Minister of FINANCE be pleased to state:
- (a) whether Government are aware of the growing menace of free flow of counterfeit currency notes from across the borders, particularly Indo-Nepal Border;
 - (b) if so, the details in this regard;
- (c) whether it is a fact that this has been the result of bad currency management of RBI; and
- (d) if so, the steps taken by Government to improve the currency management of RBI?

Social sector expenditure

- *222. SHRI C.O. POULOSE: Will the Minister of FINANCE be pleased to state:
- (a) the percentage of GDP expenditure on social sector during 1981—1991 and 1991—2001, separately;
- (b) the comparative figures of the same with the East Asian countries during the above period;

- (d) if so, the reasons therefor;
- (e) whether it is also a fact that our social sector expenditure is much low as compared to the ratio recommended by the United Nation's Development Programme; and
