Access of disabled to education

- *1. PROF. (SHRIMATI) BHARATI RAY: Will the Minister of SOCIAL JUSTICE AND EMPOWERMENT be pleased to state:
- (a) whether India has more than five crore disabled people;
- (b) whether over 98 per cent of them have little or no access to education and scholarships are given only to deserving disabled students with limited means; and
- (c) if so, the steps being taken by Government to provide a helping hand for the disabled persons in view of their great success in every field?

Will the Minister of HEAVY INDUSTRIES AND PUBLIC ENTERPRISES be pleased to state:

(a) whether it is a fact that operation at Tandur Plant of Cement Corporation of India (CCI) has resumed;

- (b) the installed capacity of the plant;
- (c) whether his Ministry has released the amount for working capital and modernisation, as assured by him; and
- (d) if not, when his Ministry is going to released the funds?

- (d) further steps being taken by Government to pursue the matter with the remaining States?

Institutions for disinvestment

- (a) whether names of certain institutions have been forwarded to Government for disinvestment;

due to sickness and Government are forced to contribute for their maintenance annually?

Prevention of Anthrax

Unauthorised constructions in the Capital

- (e) the steps taken to prevent the untimely and unnatural deaths?

Bungalows identified for demolition and new construction

- (a) whether it is a fact that there are large number of old bungalows in metropolitan cities which despite spending

- (b) if so, whether there is any proposal to demolish them and construct new bungalows in their places; and
- (c) the number of such bungalows identified by Government upto 31st October, 2001, for demolition and construction of new ones in their place?

Completion of shareholders' agreement for privatisation

- (a) the details of organisations in which shareholders' agreement for privatisation has been completed;
- (b) the disinvestment target set and whether Government will be able to meet the target; and

Shortage of dwelling units

(c) if so, the details thereof and the time frame?

 - (c) if so, the reasons therefor; and

(d) the action taken by Government on both the counts?

- (a) the reasons for withdrawal of Singapore Airlines from the process of disinvestment of Air India; and
- (b) the precautionary measures taken to prevent such withdrawal from the disinvestment process?
