- (a) whether it is a fact that commercial production of crude oil in Sudan through joint ventures of ONGC Videsh and Sudanese Government has started:
 - (b) if so, the details thereof; and
- (c) the quantity and the rate at which crude oil from Sudan will be made available to India?

Transactions by big firms in NSE and BSE

- (a) whether it is a fact that out of the total transactions carried out in NSE and BSE during the first six months of the year 2003-04, over 50 per cent contribution was made by ten big firms only;

- (c) the names of such ten big firms which made the maximum contribution in

the transactions of the said exchanges togetherwith the percentage of their contribution in terms of the total transactions?

Increase in account maintenance charges

- (d) if so, what is the progress so far made by States and how many States have agreed to meet the target fixed in this regard?

Increase in area under irrigation

Paid-up capital for new entrants in aviation sector
