- (c) whether Government are being pressed to increase the capital expenditure to tide over the present situation; and

- (c) whether it subsequently turned out to be a case of false alarm;
- (d) if so, the details thereof and the reasons therefor;
- (e) the system which was in place at the time of the incident and the details thereof and the points at which this system was breached; and
- (f) whether any accountability has been fixed?

### Aircrashes of small aircrafts
