#### Rise in tourist inflow

#### \*381. DR. KARAN SINGH: DR. T. SUBBARAMI REDDY:

Will the Minister of TOURISM be pleased to state:

- (a) whether tourist inflow for seven month period ending August, 2005 is up by 15.6 per cent to 2.37 Million against 2.05 Million in corresponding period last year;
- (b) whether the annual tourist inflow has been around 2.3 Million till 2003;
- (c) whether with the current growth rate, the tourist inflow is likely to cross 4 Million mark in 2005;
- (d) what steps, Government propose to take, to improve other facilities in India so that tourist inflow is further improved; and
- (e) what concrete steps Government propose to take to provide security to foreign tourists and also hotel and other facilities in various parts of the country?

#### New irrigation projects

- \*382. SHRI T.S. BAJWA: Will the Minister of WATER RESOURCES be pleased to state:
- (a) whether Government propose to start any new irrigation projects to provide irrigation facilities to farmers;
  - (b) if so, the details thereof;
- (c) whether Government have announced any package for the farmers of Jammu and Kashmir;
  - (d) if so, the details thereof; and
- (e) by when this package is likely to be given?

#### New opium policy

- (a) whether Government have brought into force a new rule of moisture in its new opium policy, if so, the details thereof;
- (b) whether as a result of this policy the small farmers engaged in the cultivation

of opium would suffer losses as they would be deprived of lease of land; if so, the number of farmers of the country who would suffer losses due to this policy of Government alongwith the State-wise details thereof;

- (c) whether Government would benefit as a result of this new opium policy; and
- (d) if so, the details thereof; and if not, the reasons for formulation of this policy?

#### Check on influx of Afghani heroin

- \*384. SHRIMATI BIMBA RAIKAR: Will the Minister of FINANCE be pleased to state:
- (a) whether the recent seizures of narcotics, especially heroin by the Directorate of Revenue Intelligence personnel in Delhi indicate that the contraband originating from Afghanistan is conduited to world markets *via* Delhi;
- (b) whether the majority of offenders nabbed by the DRI are from Ghana, Nigeria and other African nations; and
- (c) what steps are being taken to check the influx of Afghani heroin into the country for onward carriage?

### Acquisition of new planes for Air India and Indian Airlines

- (c) by when the orders would be placed with the manufacturing companies and planes delivered to the airlines; and
- (d) what is the total amount of expenditure involved in these deals and the present status of the same?

### Loans to SSIs and agricultural sectors by public sector banks

- (a) the measures taken by Government to provide loans to small scale industries and agricultural sectors through public sector banks at cheap rate of interest;

- (c) what are the terms and conditions and time limit for loans without security;and
- (d) details of loans sanctioned to small scale industrial units by banks during the past three years, State-wise?

#### Autonomy to PSUs

- (c) whether National Commission on Farmers recommended for basic changes in the mindset for credit delivery;
- (d) whether the panel in its second report formulated a new livelihood concept and called for its implementation through a proposed multi-crore budget; and
- (e) if so, the States which have agreed to participate in the rehabilitation package of sick co-operative banks?

### Findings of the probe into fire on ONGC platform

#### Availability of LPG cylinders at Fair Price Shops for BPL families
