# Dr. M.S. Swaminathan's recommendations on agricultural sector

- \*261. SHRI PREM CHAND GUPTA: Will the PRIME MINISTER be pleased to state:
- (a) whether it is a fact that agricultural scientist, Dr. M.S. Swaminathan has come out with a report containing far reaching recommendations for achieving high growth in agriculture and making the farm produce competitive:
- (b) whether the recommended agricultural reforms envisage massive investment in the agricultural sector by both the public and private sectors; and
- (c) if so, the details of these recommendations and Government's policy thereon?

#### Prime Minister's Japan visit

- \*262. SHRI RUMANDLA RAMA-CHANDRAIAH: Will the Minister of EXTERNAL AFFAIRS be pleased to state:
- (a) whether the Prime Minister's visit to Japan has been successful;

- (b) if so, whether Japan has agreed to provide aid that was stopped due to the Pokhran test;
- (c) to what extent Japanese investment in India would increase; and
- (d) if so, to what extent these agreements would help?

#### Amendment to Industrial Disputes Act, 1947

- \*263. SHRI KARNENDU BHATTA-CHARJEE: Will the Minister of LABOUR be pleased to state:
- (a) whether Government's attention has been drawn to the news-report captioned "Central labours to make lay-offs easy" which appeared in the 'Newstime' dated the 23rd February, 2002; and
- (b) the safeguards taken/proposed to be taken to protect interests of labour before amending the Industrial Disputes Act, 1947 to lay off employees without Government's permission?

#### Ban on duplicate brands of goods

#### Use of IT in SSI sector

- (b) if so, whether the Government of Karnataka has requested to allocate 6000 MT rice at the BPL rates; and
- (c) if so, the action taken by Government in this regard?

#### Foodgrain stocks

#### International support to Pakistan on Kashmir issue

- (a) whether Government have taken note of the fact that on January 4th, 2002, when Pakistan's spokesperson announced from Kathmandu that struggle of Kashmiris for implementation of the UN Security Council resolutions, recognizing right of the people of Jammu and Kashmir for self determination, was their indigenous movement and could by no stretch of imagination be called terrorism, the British Prime Minister from Bangalore and the U.S. Defence Secretary of State from Washington supported Pak-position as strong; and
- (b) if so, Government's reaction thereto to set the international scenario in right perspective?
