Funds provided to NGOs under welfare schemes

*1. SHRI SATISH PRADHAN: Will the Minister of SOCIAL JUSTICE AND EMPOWERMENT be pleased to state:

(a) whether Government have received a large number of complaints about the way same NGOs got money under different kind of welfare schemes which are not producing good results; and

(b) if so, Government's response thereto and the steps taken or proposed to be taken in this regard?

Sex determination tests

*2. SHRI MANOJ BHATTACHARYA: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) whether it has come to Government's knowledge that despite the enactment of the stringent laws banning the use of pre-conception technologies, there is open advertisement occasionally in various magazines inviting the eligible couples to choose the sex of their unborn child;

(b) if so, the details thereof and Government's reaction thereto; and

(c) the steps taken/proposed to be taken

to tackle such flagrant violation of legal provisions?

Expansion of health care in Orissa

Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) whether it is a fact that Orissa Government has submitted a proposal of Rs. 502 crores for expansion of health care;

(c) whether the State Government has also taken up the issue of establishment of a super special hospital on the lines of All India Institute of Medical Sciences, New Delhi; and

(d) if so, the status of the project?

Commitment for free-to-air channels

*4. SHRI SANJAY NIRUPAM: Will the Minister of INFORMATION AND BROADCASTING be pleased to state:

(a) whether Government have given any commitment to provide 70 free-to-air channels in 72 rupees under the CAS regime; and

(b) if so, the channels falling under this category and the basis of this assessment?

Trade agreement with China

(a) the details of trade agreement between India and China signed during the Prime Minister's recent visit to China;

(b) the level of trade between the two countries specifying the quantities and values of the commodities exported to and imported from China before the signing of the agreement; and

(c) the steps taken/proposed to be taken by Government to achieve the targets now set in the new agreement?

Export of mackerel shoals

(a) whether Government propose to take any action for exporting huge mackerel shoals found off East-coast in the Bay of Bengal; and

(b) the incentives proposed to be given to the fishermen for this purpose?

Setting up of Fast Track Courts

New Rohini Residential Scheme

(a) whether it is a fact that DDA has launched a new Rohini Residential Scheme;

(b) the reasons for launching such a scheme when all the registrants for the original 1982 Rohini Scheme have not been allotted the residential plots, so far;

(c) the number of registrants who are awaiting allotment of a plot in different categories; and

(d) by when they are likely to get a plot?

Foreign technology collaborations

*10. SHRIMATI SHABANA AZMI: Will the Minister of COMMERCE AND INDUSTRY be pleased to state:

(a) whether in a bid to promote foreign technology collaborations, the Centre has liberalized the policy with regard to foreign technology agreements further;

(b) if so, the main norms that have been liberalized;

(c) to what extent it would be helpful; and

(d) to what extent companies would be allowed to pay royalty payment to their foreign partners?

Treatment for Angioplasty and CABG in Government recognised hospitals

*11. MAULANA OBAIDULLAH KHAN AZMI: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to refer to the answer to Unstarred Question 3151 given in the Rajya Sabha on the 21st April, 2003 and state:

(a) the number of days for which a CGHS beneficiary can obtain treatment for undergoing Angioplasty and CABG (Open Heart Surgery) on admission to a Government recognised hospital; and

(b) the position with regard to the conditions/restrictions imposed for such treatment and entitlement for room rent, medicines, doctors visit, etc. which a CGHS beneficiary could obtain for further treatment in such cases in 1999, giving details thereof?

Import of Set Top boxes

Demolition of cell phone towers in Delhi

(c) the expected impact on the cell phone companies, which are using the towers for their business purpose?
