 - (c) if not, the reasons therefor?

Procurement made by DGS & D for WB/ADB aided projects

(a) the details of procurement made by DGS & D for World Bank/Asian Development Bank aided projects for the last three years and also the purchases effected in terms of indents, number of

 - (e) if so, the details thereof; and
 - (f) if not, the reasons therefor?

Waiving off the loans of Punjab Government
