Excise duty on medicines

*281. DR. (SHRIMATI) NAJMA A. HEPTULLA: Will the Minister of FINANCE be pleased to state:

- (a) whether it is a fact that Government have decided to impose excise duty on medicines on maximum retail price instead of the price at which consumers buy medicines;
- (b) whether it is also a fact that duty has been hiked to 35 per cent to make it further difficult for the daily users to buy medicines;
- (c) what is the reason behind this sudden hike and how many medicines have been covered/spared by this hike; and
 - (d) the details thereof?

Streamlining of procedure in respect of education Loans

- *282. SHRI N.R. GOVINDRAJAR: Will the Minister of FINANCE be pleased to state:
- (a) the details of the education loan provided by various public sector banks in Tamil Nadu;
 - (b) whether getting education loan from

- (d) the steps being taken to streamline this system so that better service can be provided to the student community by the banks?
