Pending cases in High Courts and Subordinate Courts

- (a) the number of pending cases in various High Courts and Subordinate Courts in the country and the number of judges available to deal with them till 31st December. 2001:
- (b) the norms fixed for the number of judges as per 5/10 lakh population; and
- (c) the number of vacancies of judges lying vacant till date, State-wise, and by when it will be filled up, so as to dispose of pending cases in the above mentioned courts?

Expensive cancer treatment
