Conservation and restoration of statue of Lord Gomateshwara

*361. SHRI LALIT SURI: DR. VIJAY MALLYA:

Will the Minister of CULTURE be pleased to state:

- (a) whether it is a fact that the world's tallest statue of Lord Gomateshwara and its supporting structures need to be strengthened;
- (b) if so, the steps undertaken by the Archaeological Survey of India (ASI) for conservation and restoration of the heritage structure; and
- (c) whether there is any proposal with the ASI for installing a lightning conductor to protect the statue?

Dues of Post Matric Scholarship Scheme

- (c) the reasons for growing accumulation and the steps taken for regular clearance of such dues?

Financial assistance to Sanskrit Pandits

the HRD Department of the Government of Sikkim and an amount of Rs. 55,000/-only was paid to the Pandits for three years as backlog, if so, the reasons therefor; and

(c) whether it is a fact that for the year 2004-05 they have not been paid till date and if so, the reasons therefor?
