#### Decline in industrial growth

- \*421. SHRI SANTOSH BAGRODIA: Will the Minister of COMMERCE AND INDUSTRY be pleased to state:
- (a) whether it is a fact that one of the reasons for decline in industrial growth is diversion of a considerable part of budgetary resources from investment to consumption; and
- (b) in what manner industrial growth can be achieved this year *viz-a-viz* last year?

### Ban on import of coconut

- \*422. SHRI H.K. JAVARE GOWDA: Will the Minister of COMMERCE AND INDUSTRY be pleased to state:
- (a) whether it is a fact that large scale import of coconut and its products has caused price crash in Karnataka and other States; if so, the details thereof;
- (b) whether the State Government of Karnataka has requested Government to ban the import of coconut and its products; and
- (c) if so, the details of the steps taken so far in this regard?

### Service tax regime

- \*423. SHRI RAMA MUNI REDDY SIRIGIREDDY: Will the Minister of FINANCE be pleased to state:
- (a) whether it is a fact that the service tax regime is set to go on-line;

- (a) whether it is a fact that the Oil companies in India will find it difficult to retain prices of petroleum products at current level in case the increase in crude prices is not offset by duty and tax relief by Government;
- (b) if so, whether Government propose to come to the rescue of oil companies; and
  - (c) if not, the reasons therefor?

#### Profit earned by AI

- (a) whether Air India has made any profit for the year 2001-2002;
