### Allocation under SGRY to Gujarat

- \*461. SHRI RAJU PARMAR: Will the Minister of RURAL DEVELOPMENT be pleased to state:
- (a) whether Government have any scheme to launch Sampoorna Grameen RozgarYojana;
  - (b) if so, the salient features thereof; and
- (c) the funds allocated/proposed to be allocated to the State of Gujarat under the scheme?

### Funds allocated for modernisation of Indian Army

- \*462. SHRI JANARDHANA POOJARY: Will the Minister of DEFENCE be pleased to state:
- (a) whether it is a fact that the Indian Army has embarked on modernisation through procurement of latest weapons and strategic equipments;
- (b) if so, the amount sought and allocated for the purpose;
- (c) whether it is a fact that the modernisation process of the defence forces is hampered by scant release of funds;
- (d) if so, the reasons for curtailment of funds: and

(e) if not, the amount sought by the defence forces and allocated by Government for modernisation during the last three years, year-wise?

# Induction of defence personnel into other branches of Government
