Purchase of pipes by GAIL

*301. SHRI RAJU PARMAR: SHRI R.K. ANAND:

Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

- (a) whether the Gas Authority of India Limited (GAIL) has invited tenders for purchase of expensive longitudinallywelded pipes for laying down its Dahej-Vijaipur pipeline project;
- (b) if so, what are the details in this regard and whether GAIL is losing more than Rs. 450 crores on the purchase of these pipes ignoring the advice of its authorised Belgium based Engineers Consultant; and
- (c) whether Government would probe the matter and if not, the reasons therefor?

Utilisation of Godavari water

- *302. SHRI RUMANDLA RAAMA-CHANDRAYYA: Will the Minister of WATER RESOURCES be pleased to state:
- (a) whether Government of Andhra Pradesh has entered into an agreement with the Austrian Government for utilisation of Godavari water in hydel and irrigation projects;

- (b) whether water going waste and flowing into Bay of Bengal will be utilised with the implementation of this agreement; and
- (c) by when the work on the proposed projects is likely to be commenced?

Assistance to Assam from Social Security Fund

- *303. SHRI DWIJENDRA NATH SHARMAH: Will the Minister of FINANCE be pleased to state:
- (a) whether Government have released financial assistance to Assam from Social Security Fund;
- (b) if so, the details of assistance released to the State during the last three years; and
 - (c) if not, the reasons therefor?

Storage capacity of reservoirs

- (a) whether it is a fact that the storage capacity of major reservoirs of the country has come down drastically due to excessive silting;

- (b) if so, the details of the storage capacity of various reservoirs at the time of inception and now with special reference to Andhra Pradesh;
- (c) whether there is any proposal to dredge the reservoirs; and
 - (d) if so, the details thereof?

Foreign exchange reserves

- (c) whether in its report on trends and progress of banking in India in 2002-03, the Reserve Bank of India has given details of a mechanism put in place to streamline the cooperative banking; and
- (d) if so, the other reasons for rejecting the 88 proposals?

Disbursement of crop loans in M.P.
