Blue print of Tsunami Warning System

- (a) whether a Canadian scientist accompanying the Canadian Prime Minister during his recent New Delhi visit, made presentation of a blue print for setting up a Tsunami Warning Centre in the Indian Ocean;
- (b) if so, the broad features and estimated cost of the Tsunami Warning Centre and whether the system is proposed to be set up in a joint venture between the Ocean States;
- (c) whether the scientist had made such an offer before Tsunami disaster also; and
- (d) if so, Government's response thereto?

Creation of special economic regions
